<b>Term Begins:</b>	First Tuesday after the first Monday in January following the election January 7, 2025
<b>Qualifications:</b>	Registered voter in Duval County and live in the subdistrict. Must also qualify for at least one of the following: <ul style="list-style-type: none"> <li>▪ Actively engaged in or retired after 10 years of being engaged in agriculture as defined in s. 570.02 Florida Statutes</li> <li>▪ Employed by an agricultural producer</li> <li>▪ Own, lease, or actively employed on land classified as agriculture under s. 193.461 Florida Statutes</li> </ul>
<b>Term of Office:</b>	4 years
<b>Electorate:</b>	Registered voters of the district (Duval County)
<b>Qualifying Period:</b>	Noon, June 10, 2024, through Noon, June 14, 2024
<b>Method of Qualifying:</b>	<ul style="list-style-type: none"> <li>▪ <b>Qualifying fee: \$25.00</b> (<i>May be paid by personal funds- cash, money order, cashier's check, personal check</i>)</li> <li>▪ <b>Petition Process: 25</b> valid petitions required</li> </ul>
<b>Filing for Office: Forms Required</b>	<ul style="list-style-type: none"> <li>▪ <b>DS-DE 9</b> Appointment of Campaign Treasurer and Designation of Campaign Depository</li> </ul> <p><i>*Pursuant to 99.061(3) a candidate who does not collect contributions and whose only expense is the filing fee is not required to appoint a campaign treasurer or designate a primary campaign depository</i></p> <ul style="list-style-type: none"> <li>▪ <b>DS-DE 84</b> Statement of Candidate</li> </ul> <p><b>OR</b></p> <ul style="list-style-type: none"> <li>▪ <b>AFFIDAVIT OF INTENTION</b></li> </ul> <p>Special district candidates who <b>do not intend</b> to collect contributions or make expenditures are required to file the Affidavit of Intention with the Supervisor of Elections (SOE)</p>
<b>Petition Information</b>	<ul style="list-style-type: none"> <li>▪ <b>DS-DE 104</b> Candidate petition</li> <li>▪ <b>May 13, 2024</b>, prior to Noon, all petitions for verification must be submitted to the SOE office.</li> <li>▪ The SOE shall be <b>paid in advance</b> the sum of 10 cents for each signature verified. (FS 99.097)</li> </ul>
<b>Qualifying Forms And Fees</b> All items must be filed before the end of the qualifying period.	<ul style="list-style-type: none"> <li>▪ <b>DS-DE 302NP</b> Candidate Oath (<b>Notarized</b>)</li> <li>▪ <b>FORM 1</b> Statement of Financial Interests 2023</li> <li>▪ <b>Soil &amp; Water Statement of Qualification (Notarized)</b></li> </ul>
